#### Installation

- 1. For best results, use your projector in a darkened room.
- 2. Place the projector on a flat, level surface in a dry area away from dust and moisture.
- 3. Do not place your projector in direct sunlight, near heaters or heat radiating appliances.
- 4. Exposure to direct sunlight, smoke or steam can harm internal components.
- 5. Handle your projector carefully. Dropping or jarring can damage internal components.
- 6. Do not place heavy objects on top of the projector.

#### **Fire and Shock Precautions**

- 1. Ensure that there is sufficient ventilation and that vents are unobstructed to prevent the build-up of heat inside your projector. Allow at least 12 inches (30 cm) of space between your projector and a wall.
- 2. Prevent foreign objects such as paper clips and bits of paper from falling into your projector.
  - Do not attempt to retrieve any objects that might fall into your projector. Do not insert any metal objects such as a wire or screwdriver into your projector. If something should fall into your projector, disconnect it immediately and have the object removed by a qualified NEC service personnel.
- 3. Do not place any liquids on top of your projector.
- 4. Do not look into the lens while the projector is on. Serious damage to your eyes could result.
- 5. Keep any items such as magnifying glass out of the light path of the projector. The light being projected from the lens is extensive, therefore any kind of abnormal objects that can redirect light coming out of the lens, can cause unpredictable outcome such as fire or injury to the eyes.
- 6. Do not cover the lens with the supplied lens cap or equivalent while the projector is on. Doing so can lead to melting of the cap and possibly burning your hands due to the heat emitted from the light output.
- 7. The projector is designed to operate on a power supply of 100-240V AC 50/60 Hz. Ensure that your power supply fits this requirement before attempting to use your projector.
- Handle the power cable carefully and avoid excessive bending.
   A damaged cord can cause electric shock or fire.
- 9. If the projector is not to be used for an extended period of time, disconnect the plug from the power outlet.
- 10. Do not touch the power plug during a thunderstorm. Doing so can cause electrical shock or fire.

- ★ Warning- Reset the "Clear lamp hour" function from the On-Screen Menu "Setup" menu after replacing the lamp module (refer to page 24).


# **Powering On/Off the Projector**

# **Powering On the Projector**

- **1.** Remove the lens cap.
- **2.** Ensure that the power cord and signal cable are securely connected. The Power LED will turn **orange**.
- 3. Turn on the lamp by pressing "On/Standby" button on the control panel. And the Power LED will flash green.
  The startup screen will display for 20 seconds and the Power LED will turn green.
- **4.** Turn on your source (computer, notebook, video player, etc.). The projector will detect your source automatically.
- \* If the screen displays "No Input", please make sure the signal cables are securely connected.
- \* If you connect multiple sources at the same time, use the "Source" button on the remote control or control panel to select your desired source.



Turn on the projector first and then the signal sources.



# **Powering Off the Projector**

- **1.** Press the "On/Standby" button to turn off the projector lamp, you will see a message "**Power Off**" on the on-screen display.
- **2.** Press the "On/Standby" button again to confirm. Otherwise the message will disappear after **5** seconds.
- 3. The cooling fans continue to operate for about 100 seconds for cooling cycle and the Power LED will flash orange. When the light stops flashing and turns orange, the projector has entered standby mode.
  If you wish to turn the projector back on, you must wait until the projector has completed the cooling cycle and has entered standby mode. Once in standby mode, simply press "On/Standby" button to restart the projector.
- **4.** Disconnect the power cord from the electrical outlet and the projector.
- **5.** Do not turn on the projector immediately following a power off procedure.

# **Warning Indicator**

- When the "LAMP" indicator lights **solid red**, the projector will automatically shut itself down. Please contact your local reseller or service center.
- \* When the "STATUS" indicator lights **solid red**, it indicates the projector has been overheated. You will see a message "Projector Overheated" on the on-screen display. The projector will automatically shut itself down. Under normal conditions, the projector can be switched on again after it has cooled down. If the problem persists, you should contact your local dealer or our service center.
- \* When the "STATUS" indicator **flashes red** for about **10** seconds, you will see a message "The cooling fan has stopped" on the on-screen display. Please contact your local dealer or our service center.

# Adjusting the Projector Image Height

The projector is equipped with an elevator foot for adjusting the image height.

To raise the image:

- **1.** Press the elevator button **0**.
- **2.** Raise the image to the desired height angle **2**, then release the button to lock the elevator foot into position.
- **3.** Use **3** to fine-tune the display angle.

To lower the image:

- 1. Press the elevator button.
- **2.** Lower the image, then release the button to lock the elevator foot into position.
- **3.** Use **3** to fine-tune the display angle.








# Adjusting the Projector Zoom/Focus

You may turn the zoom lever to zoom in or out. To focus the image, rotate the focus ring until the image is clear. The projector will focus at distances from 4.9 to 32.8 feet (1.5 to 10.0 meters).



▶ Adjusts image distortion caused by tilting the projector (±8 degrees).

### Four Directional Select Keys

▶ Confirm your selection of items.



### **AUTO ADJ. (Auto adjustment)** ◀

▶ Automatically synchronizes the projector to the input source.

Press "PIC-MUTE" to hide image, press again to restore display of the image.

### Freeze

▶ Press "Freeze" to pause the screen image.

▶ Selects the desired aspect ratio.

### Menu

▶ Press "Menu" to launch the on-screen display menu.

### Four Directional Select Keys

Use ▲ ▼ ◀ ▶ to select items or make adjustments to your selection.

#### Enter

Confirm your selection of items.

#### Exit

Exit the OSM menu.




## **On-Screen Menus**

The Projector has multilingual On-Screen menus that allow you to make image adjustments and change a variety of settings. The projector will automatically detect the source.

# How to operate

- **1.** To open the OSM menu, press "Menu" on the Remote Control or Control Panel.
- 2. When OSM is displayed, use ◀ ▶ keys to select any item in the main menu. While making a selection on a particular page, press "Enter" key to enter sub menu.
- 3. Use ▲ ▼ keys to select the desired item and adjust the settings by ◀ ▶ key.
- **4.** Select the next item to be adjusted in the sub menu and adjust as described above.
- **5.** Press "Exit" to confirm, and the screen will return to the main menu.
- **6.** To exit, press "Exit" again. The OSM menu will close and the projector will automatically save the new settings.







# Language

### Language

Choose the multilingual OSM menu . Use the  $\, \blacktriangle \,$  or  $\, \blacktriangledown \,$  key to select your preferred language.

Press "Enter" to finalize the selection.




Image (All)

### **Brightness**

Adjust the brightness of the image.

- ▶ Press the **◄** to darken image.
- ▶ Press the ▶ to lighten the image.

### **Contrast**

The contrast controls the degree of difference between the lightest and darkest parts of the picture. Adjusting the contrast changes the amount of black and white in the image.

- ▶ Press the do decrease the contrast.
- ▶ Press the ▶ to increase the contrast.

### White Peaking

White peaking can be incrementally adjusted between 0 and 10. Click on the slider bar to adjust. The default value for computer is 10. The default value for video is 2. If the default value is changed, the display mode will change to user mode automatically.

- ▶ Setting 10 will maximize brightness and contrast.
- ▶ Setting 0 will maximize color reproduction quality.

### **Color Temperature**

Adjust the color temperature. At higher temperature, the screen looks colder; at lower temperature, the screen looks warmer.

### Keystone

Adjust image distortion caused by tilting projector. (±8 degrees)

### **Aspect Ratio**

Use this function to choose your desired aspect ratio.





# Image (All)

- ▶ 4:3 : The input source will be scaled to fit the projection-screen.
- ▶ 16:9: The input source will be scaled to fit the width of the screen.

### **Display Mode**

There are many factory presets optimized for various types of images.

- ▶ Presentation : For presentation.
- Video : For home theater.
- ▶ Game : For game.
- ▶ sRGB : For PC standard color.
- User : Memorize user's settings.

#### Reset

Choose "Yes" then "Enter" pressed, the display parameters on this menu will return to their factory default settings.



# Image Computer (Computer mode)

### **Auto Adjust**

The projector automatically adjusts clock, phase, horizontal and vertical. With most signal sources, Auto Adjust provides the best results.

### Clock

"Clock" changes the display data frequency to match the frequency of your computer's graphic card. If you experience a vertical flickering bar, use this function to make an adjustment.

#### Phase

"Phase" synchronizes the signal timing of the display with the graphic card. If you experience an unstable or flickering image, use this function to correct it.

### **Horizontal Position**

- ▶ Press the to move the image left.
- ▶ Press the ▶ to move the image right.

### Vertical Position

- ▶ Press the to move the image down.
- ▶ Press the ▶ to move the image up.

### Reset

Choose "Yes" then "Enter" pressed, the display parameters on this menu will return to their factory default settings.





# Image Video (Video mode)

### Color

Adjusts a video image from black and white to fully saturated color.

- ▶ Press the d to decrease the amount of color in the image.
- ▶ Press the ▶ to increase the amount of color in the image.

### **Sharpness**

Adjusts the sharpness of the image.

- ▶ Press the ◀ to decrease the sharpness.
- ▶ Press the ▶ to increase the sharpness.

#### Hue

Adjusts the color balance of red and green.

- ▶ Press the ◀ to increase the amount of green in the image.
- ▶ Press the ▶ to increase the amount of red in the image.

### Reset

Choose "Yes" then "Enter" pressed, the display parameters on this menu will return to their factory default settings.

### **Menu Location**

Choose the menu location on the display screen.

### Orientation

### Front-Desktop

The factory default setting.



### Rear-Desktop

When you select this function, the projector reverses the image so you can project behind a translucent screen.

## **Lamp Hour**

Display the cumulative lamp operating time. The lamp hour in OSM is calculated by "Normal mode", when "ECO mode" is selected, the system will convert from "ECO mode" lamp hour to "Normal mode".

### Signal Type

Select signal type RGB or Video sources.

### Search Signal Lock

When this function is turned off, the projector will search for other signals if the current input signal is lost. When this function is turned on, it will search specified connection port.

### Fan Mode

Choose "High" to turn on High Altitude mode. Operates the fans at full speed continuously to allow for proper high altitude cooling of the projector. Choose "Normal" to return standard mode.



#### Remark:

The formula is: "ECO mode" lamp hours x 0.67 = "Normal mode" lamp hours.



# Setup

### Lamp Mode

Choose "ECO" to dim the projector lamp which will lower power consumption and extend the lamp life by up to 150%. Choose "Normal" to return standard mode.

### **Lamp Reminding**

Choose this function to show or to hide the warning message when the changing lamp message is displayed. The message will show up 100 hours before end of life.

### **Clear Lamp Hour**

Turns the lamp hour counter to 0 hours.

### Reset

Choose "Yes" then "Enter" pressed, the display parameters (except for Lamp Hour) on this menu will return to their factory default settings.

### Reset (All)

Choose "Yes" then "Enter" pressed, the display parameters (except for Lamp Hour) on all menus will return to their factory default settings.



# **Troubleshooting**

If you experience trouble with the projector, refer to the following information. If the problem persists, please contact your local reseller or service center.

### Problem: No image appears on-screen.

- ▶ Ensure all the cables and power connections are correctly and securely connected as described in the "Installation" section.
- ▶ Ensure the pins of connectors are not crooked or broken.
- ▶ Check if the projection lamp has been securely installed. Please refer to the "Replacing the lamp" section.
- Make sure you have removed the lens cap and the projector is switched on.
- ▶ Press "Picture Mute" button to make sure the image has not been turned off temporarily.

### Problem: Partial, scrolling or incorrectly displayed image.

- ▶ Press the "AUTO ADJ." button on the Remote Control or Control Panel.
- If you use a PC:

If the resolution of your computer is higher than  $1024 \times 768$ . Follow the steps outlined below to reset the resolution.

### For Windows 3.x:

- 1. In the Windows Program Manager, click the "Windows Setup" icon in the Main group.
- **2.** Verify that your display resolution setting is less than or equal to  $1024 \times 768$ .

#### For Windows 95,98,2000,XP:

- **1.** Open "My Computer" icon, the "Control Panel" folder, and then double click on the "Display" icon.
- 2. Select the "Setting" tab.
- **3.** In the "Desktop Area" you will find the resolution setting. Verify that the resolution setting is less than or equal to 1024 x 768 resolution.

If the projector is still not projecting the whole image, you will also need to change the monitor display you are using. Refer to the following steps.



- **4.** Follow the above steps 1-2. Click on the "Advanced Properties" button.
- **5.** Select the "Change" button under the "Monitor" tab.
- **6.** Click on "Show all devices". Then select "Standard monitor types" under the "Manufacturers" box; choose the resolution mode you need under the "Models" box.
- 7. Verify that the resolution setting of the monitor display is less than or equal to  $1024 \times 768$ .
- If you are using a Notebook PC:
  - **1.** You are required to implement the above steps of resolution setting of the computer first.
  - **2.** Switch the Notebook PC display to the "external display only" or "CRT only" mode.
- ▶ If you experience difficulty in changing resolutions or your monitor freezes, restart all the equipment and the projector.

# Problem: The screen of the Notebook or PowerBook computer is not displaying your presentation.

- ▶ If you are using a Notebook PC: Some Notebook PCs may deactivate their screens when a second display device is in use. Refer to your computer's documentation for information on how to reactivate the monitor display.

### Problem: The image is stretched when displaying 16:9 DVD.

The projector automatically detects 16:9 DVD and adjusts the aspect ratio by digitizing to full screen with 4:3 default setting.

If the image is still stretched, you will also need to adjust the aspect ratio by referring to the following:

- ▶ Please select 4:3 aspect ratio type on your DVD player if you are playing a 16:9 DVD.
- ▶ If you can't select 4:3 aspect ratio type on your DVD player, please select 4:3 aspect ratio in the on-screen menu.

### Problem: Lamp burns out or makes a popping sound

▶ When the lamp reaches its end of life, it will burn out and may make a loud popping sound. If this happens, the projector will not turn on until the lamp module has been replaced. To replace the lamp, follow the procedures in the "Replacing the Lamp". See page 29.


